SUBJECT: COMMITMENTS BY BOTH ASSOCIATIONS IN CASE OF PARTNERSHIP AGREEMENT

Dear Friends, attached outline of collaboration agreement between your Association: American Football Federation Ghana (AFFG) and our Association: International Amateur American Football League (IAAFL) to be approved by your Directive.

After the necessary changes, we will proceed to a signature of the two parties and this agreement will be automatically renewed every year.

In case of waiver of the agreement of one of the two parties, a simple letter of resignation with the signature of the President of your Association will be sufficient to cancel the agreement.

In more detail, the Convention is based on the following points:

1. VISIBILITY ① On both sides the commitment to associate the relevant logo (AFFG and IAAFL) in official publications.

AFFG logo will appear on all IAAFL panels, banners, brochures, event presentations, and all official IAAFL communication at the bottom of the page or where IAAFL will consider it appropriate graphically.

In the same way AFFG will have the IAAFL logo on panels, banners, brochures, event presentations but with some exceptions of the following afore mentioned on specific events and programs solely sponsored or co-sponsored by AFFG and other Organizations, Institutions, Embassies and Leagues other than IAAFL; whom are sensitive to such occurrence for which have an agreed exemptions and patency to intellectual materials, logos and rights in associations with AFFG as determined by law of partnership with AFFG.

- IAAFL will create a page on its www.iaafl.eu international web site dedicated to AFFG and its activities and update with news stories.
 - AFFG undertakes to communicate in real time the activities to be carried out or carried out as well as Calendar of activities as formalized and available.
 - At the discretion and availability of AFFG, the website may be implemented directly by AFFG staff who will receive privileged access as Editors of the corresponding section, as well as the possibility of inserting detailed worksheets from the teams, coaches, and players.
- IAAFL will create a user Editor on its website www.iaafl.eu so that AFFG can publish, through
 the WordPress Software, news (posts) of its activities,
 as well as AFFG authorizes IAAFL staff to posts concerning activities organized in Africa by
 AFFG.

 At the discretion of AFFG, the local teams or the national team may place the IAAFL logo on their uniform free of charge without paying Royalties, as well as IAAFL undertakes, in case of presence of interested Sponsors, to contribute financially or material to AFFG.

2. EVENTS

- IAAFL is committed to putting the AFFG logo as a partner in all events organized worldwide by IAAFL, as well as AFFG is committed to associating the name of IAAFL in all national and international events organized by AFFG with an exception of events (International games, Leagues, Clinics/Combine, Symposiums) solely or co-sponsored by AFFG and other Organizations, Institutions, Embassies and Leagues other than IAAFL; whom are sensitive to such occurrence for which have an agreed exemptions and patency to intellectual materials, logos and rights in associations with AFFG as determined by law of partnership with AFFG.
- IAAFL is committed to inviting and favoring the participation of national teams or AFFG teams in events, championships and leagues promoted by IAAFL around the world.
- AFFG commits to try to participate in international IAAFL events with one or more national teams or selection of players or the same with the presence of one or more AFFG players according to economic availability in Regional, Continental or World Selections (Ex. Team World or Team Africa)
- In all international events, IAAFL undertakes to invite AFFG Referees to join the IAAFL Crews
 of Referees, as well as offers, according to economic availability, to send IAAFL Referees at
 events organized by AFFG.
- IAAFL undertakes to sponsor, assist logistically, technically and/or advising AFFG in the
 organization of any event organized by AFFG at the discretion of AFFG with simple request
 from AFFG.

3. TECHNICAL SUPPORT

- IAAFL undertakes to carry out Camps for players, Training for Coaches and Referees of AFFG with simple request from AFFG asking simply to cover the costs of local transport and food and accommodation of the trainer(s)- {Volunteer Contract without benefits}, with relative right to Certification and/or title of IAAFL recognized by the Italian Olympic Committee and by the CSIT (Confederation Sportive Travailliste et Amateur), as well as organizing at reduced costs possible Stages of Players, Coaches and Referees in Italy, headquarters of IAAFL.
- AFFG undertakes to recognize the Certificates and/or Titles delivered by the IAAFL trainer(s) and to validate them at national level.
- IAAFL is committed to having open a preferential channel for AFFG for all technical issues
 relating to the American Football world, including free access to the IAAFL publications
 library. For this purpose, IAAFL will designate one or more IAAFL people as direct
 correspondents for AFFG, as well as provide the names of the persons authorized to contact
 the IAAFL Technical Department.

4. PLAYERS

- The two associations undertake to leave the doors open in order to favor possible exchange
 of players between the two associations, if the economic, visa and logistic conditions allow it
 but with some exemptions on contracts and sign-on fee of players which will be solely
 determined and facilitated by those directly concerned and with the rights to undertake such
 agreements as to contracts with players as with the provision of the ethics of practice and
 the law.
- IAAFL is committed to pointing out to IAAFL agents with the permit of AFFG on possible highlevel players within its territory so that they can participate in Combine in Semi or Professional Leagues in the World, as well as AFFG undertakes to receive in its territory possible agents who collaborate with IAAFL in order to facilitate the vision of the AFFG players to these agents.

Other proposals for collaboration can be implemented in the future with written consensus of both parties.
